Who Else is Saving Energy and Money?

- A dairy in Tulare is going to install 418 320-watt pulse-start HID low bay fixtures in their barn. The estimated rebate for this is over \$20,000, with energy savings estimated at 908,000 kWh annually.
- A Central Valley citrus grower is converting to a micro-irrigation system for his 130 acres. This, combined with a new 40 hp pump with a premium efficiency motor, will provide a total incentive of nearly \$24,000 and over 250,000 kWh of energy savings.
- A food processor in the LA Basin recently installed floating head pressure controls, compressor variable speed drives and condenser variable speed fan controls to achieve and estimated \$133,000 in rebates and save nearly 1,441,000 kWh annually.

Incentives for Lighting A Bright Idea

Did you know that you can save money by improving lighting efficiency through **Ag Efficiency Plus**?

There are over 50 lighting options available through **Ag Efficiency Plus**. Rebates range from \$2 up to \$100 per fixture upgraded. In addition to the rebates, the kWh saved by implementing these changes will save you money on your next electric bill.

For example, many of our **Ag Efficiency Plus** participants are installing pulse-start HID or T8 florescent electronic ballast lighting fixtures. Rebates for such fixtures range from \$12.50 up to \$100 per unit installed, depending on what best suits their needs.
